This is in reference to CBDT Circular No. 27/2019 wherein para 2(e) reads as under:

"(In all cases at stations connected through the VSAT or with limited capacity of bandwidth (list of such stations shall be specified by the Pr. DGIT (System))"

As per the above Circular No. 27/2019 the list of the Income Tax buildings which have limited bandwidth are given in Annexure-A {List of 8 sites of Income Tax buildings on VSAT and 5 other sites where the bandwidth is low i.e. total of 13 sites}.
