Note 3:

All the respective Pr.Cs.IT/Cs.IT(Admn) of City, Central and Other Charges in Mumbai are requested to direct their above referred concerned Jt./Addl. C.I.T. to report for duty to the concerned CIT(DR), ITAT, Mumbai of the respective Benches and take their

Note 2:




