2. **The Sr. AR posted to the Benches, after going through the cause list for the week will manage the work of Bench in such a fashion that considerable cases are to be dealt by officers, who are posted as per the above list but in case of more than reasonable case is posted then regular Sr. AR will take up cases on respective day.**

Therefore, all the Sr. ARs are directed not to leave office on Thursdays and Fridays before 6 p.m. without taking their files/briefs for next day/ week and without the prior permission of their respective CIT (DR) as well as CIT (DR), ITAT (Admn.), Mumbai before finalization of Work Allocation. The allocation of COURT Nos. to above named officers for duty on Friday will be notified separately.

4. The appeal folders being made available in advance in order to facilitate better representation on behalf of the Department. Hence, the concerned Officers are directed to collect the Appeal folders immediately from the Inspector / TA of the Bench indicated above. **All the officers are required to keep their official mobile phone 'ON' on continuous basis** irrespective of whether they have been assigned duties or not so as to meet any urgency.

**Note 1:**

*All the respective Pr.Cs.IT/CsIT(Admn) of City, Central and Other Charges in Mumbai are requested to direct their above referred concerned Jt./Addl. C.I.T. to report for duty to the concerned CIT(DR), ITAT, Mumbai of the respective Benches and take their files/briefs well in advance without any failure or excuse. **In case the concerned Jt.CIT/Addl.CIT has been sanctioned any leave or is unable to attend duty for any reason, then the concerned Pr.Cs.I.T./CIT (Admn) shall depute some other Jt.CIT/Addl. CIT Rank Officer from his charge so that the Bench cases do not go unrepresented by the Department before the ITAT, Mumbai.** Subject to the above, no request for any change/modification of duties will be entertained in respect of Work Allocation.*

**Note 2:**

All the Jt.Cs.I.T./Addl. Cs.I.T being allotted the above duty are required to note down whatever directions are given by the Hon'ble Members in respect of any case and do all the necessary follow up exercise on day to day basis and during the relevant period itself. When required, a copy of such notings/directions may be forwarded in writing to the concerned CIT (DR) of the Bench.

**Note 3:**

As per the directions of the Pr. CCIT vide letter No. MUM/Pr.CCIT/Co-ord/U-II/ITAT/2015-16/1162, dated 10.11.2015 adjournment should be taken only in exceptional circumstances. Before taking such adjournment the concerned CIT(DR) of the Bench should invariably be consulted.


