

ORDER NO. 26 OF 2017

Consequent upon the approval of ACC and in continuation of order No.15 of 2015 dated 30.01.2015 and order No. 55 of 2015 dated 27.04.2015 the following officers are, hereby, promoted to the grade of Principal Commissioner of Income Tax (HAG scale of pay (Rs. 67,000 – 79,000/-) (pre-revised) by maintaining their *inter-se-seniority* w.e.f. the date of assumption of charge of the post.
