

(Res.-I) (Pt.II) dated 15.06.2018. Further, this order is subject to outcome of any other court case(s) pending in any court of law, anywhere.
3. The above list of officers does not purport to be a seniority list and the *inter-se* seniority between the Promotees and Direct Recruits will be governed by the relevant provisions of Indian Revenue Service Rules, 2015.
4. The Principal CCsIT, concerned, to which the officers are posted, shall ensure that they are clear from vigilance angle, no disciplinary /criminal proceedings are pending against them and are not under suspension before they are allowed to assume charge as ACIT on *in situ* basis and till their formal posting is decided by the Competent Authority/Placement Committee.
5. Such appointments shall not confer any right to the officers for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DoP&T as
