**PUBLIC NOTICE**

In view of the developing Covid situation, and in view of the limitations placed by the authorities under the Disaster Management Act 2005, the functioning of the Income Tax Appellate Tribunal is being curtailed with effect from today, and till 1<sup>st</sup> May 2021, as follows:

- a) Only three combinations of Members, sitting in division benches, will function during this week. Therefore, in addition to E, F, H and SMC benches, which were scheduled to be non-functional this week, A, I, and K benches will also not function.
- b) In case there are good reasons for urgent hearing of a matter such as opting for Vivad Se Vishwas Scheme or pending garnishee proceedings, or when an assessee, for good and sufficient reasons, wants to proceed with any of the matter listed before the adjourned benches, the assessee can move an application for hearing of such matters by a functional bench. Such applications, if any, may be sent by email to [yps.mumbai@itat.nic.in](mailto:yps.mumbai@itat.nic.in)
- c) In view of the fact that the ITAT office is henceforth functioning with only 15% staff strength, no visitors can ordinarily be entertained- except when wholly unavoidable. Any documents required to be filed in the ITAT can be dropped in two drop-boxes placed- outside the appeal receipt room and outside the judicial section. The acknowledgments will be issued within 2-3 days of receipt of such documents.
- d) On Fridays, only stay applications, VsVs matters, or other matters, in respect of which the assessee has moved an application for hearing on urgent basis, will be taken up for hearing.


