**Re: Resumption of physical functioning of the Income Tax Appellate Tribunal, Mumbai benches**

On account of the sudden surge in covid infections towards the end of December 2021, and vide order dated 3<sup>rd</sup> January 2022, the physical functioning of the courts was placed under suspension, and this suspension of physical functioning of courts was extended, from time to time, till 4<sup>th</sup> February 2022.

**Note 6:** Part heard cases will be argued by the Sr. ARs who has argued the case earlier.


