**Note 5:** Any request for exemption should be submitted to the CCIT- 5, Mumbai. Direct request to  
CIT(DR), ITAT(Admn) and ITO(HQ), ITAT(Admn) may be avoided.

**Note 6:** Part heard cases will be argued by the Sr. ARs who has argued the case earlier.


**Note 7:** I.T.O. of concerned bench will provide kutchra and final cause list and case files  
to officers on roster duty.


**Note 8:** Last minute leave of officers on roster duty will not be entertained. If officer on roster  
duty applies for leave he will have to provide replacement himself.






